

Register of interests for Blaby Stokes governors

Owing to the composition of governing body being drawn from local public and private sector organisations, transactions may take place with organisations in which a governor has an interest. All transactions involving such organisations are conducted at arm's length and in accordance with the school's financial regulations and normal procurement procedures.

This register is a statutory document for the governing body and careful consideration has been given to it when completing it. Where there has been any doubt, the presumption has been in favour of disclosure, to support transparency and accountability. It is important that governors and staff not only act impartially, but are also seen to act impartially. Governors have a legal responsibility to avoid conflict between their business and personal interests and affairs and those of the school and to declare an interest likely to lead to questions of bias when considering any item of business at any meeting of governors.

The register is reviewed annually. Governors are aware of the need to declare any changes as and when they occur.
